As Principal Sponsor you benefit from:


- Principal Sponsor will be given the opportunity to feature in short 90 second pre-event video clips for marketing purposes. **New for 2026.**
- Prominent logo presence on the event programme.
- Featured on the first and last slide in the show presentation, and the intermission slide.
- Have first choice placement for x2 pop-up stands (provided by you) in the event reception area, where participants will gather for networking drinks prior to the show and during the intermission.
- Be the only sponsor with a banner on stage (provided by you) OR should digital banners be used (provided by LAW). The Principal Sponsor will appear on the screens intermittently throughout the evening. Law At Work will also be featured along with the Speaker's logo and if they're being sponsored by a Supporting Sponsor, their logo will be featured too.

- Be guaranteed two speaker slots in the event programme for two members of your business.
- Have the opportunity to have a 45 minute executive briefing with one of our international speakers (subject to their diary).
- Receive four complementary tickets for the event, which may be designated for staff or clients (Value £55 each).
- Receive a discount code for 20% off x30 further client / staff tickets.
- Be publicly thanked by the event host.


SUPPORTING SPONSORS

Supporting Sponsors

The Supporting Sponsors will receive supporting billing “proudly supported by [XXXXX]” or (by the display of a small logo) on the event programme. There are several Supporting Sponsor packages, which will be handled slightly differently but all will benefit from:


- x2 complementary tickets for the event, which may be designated for staff of clients (value £55.00 each).
- Featured (name / logo) within the first and last slide of the event.
- Publicly thanked by the event host, as a collective of Sponsors.
- Given strong preference if you wish to provide a speaker from your business in the event programme (subject to the overall balance of speaker applicants).
- Have the opportunity to provide merchandise or literature to every delegate.
- Have the opportunity to display one “pop-up” stand in the Freedom Centre auditorium.
- Have the opportunity to have a message included in a collective marketing e-mail sent to the event attendee list.
- Logo presence on the event programme.

Keynote Speaker Sponsor

£3,000 (x3 available)

Name and logo will be displayed as the speaker takes the stage. Will be mentioned by the host and in the programme. Choice of speakers will be allocated to Sponsors in the order they confirm agreement to Sponsor.

Pre-show Refreshments Sponsor

£3,000 (x1 available)

Name and logo will be displayed at the drinks stations during the pre-show networking and in the programme.

Intermission Refreshments Sponsor

£3,000 (x1 available)

Name and logo will be displayed at the drinks / nibbles stations during the intermission and in the programme.

Programme Sponsor

£3,000 (x1 available)

This Sponsor will pay a fee which will enable this to be professionally sourced. Name and logo will be displayed in the event programme.



SPONSOR GUIDANCE

As a Sponsor, will I be guaranteed a presentation slot?

Not necessarily. If we have a high number of Sponsors, we can't guarantee a presentation slot for everyone. In some cases, a proposed presentation may also not be considered suitable for the event.

That said, don't worry, we've yet to decline a presentation or presenter!

Principal Sponsors are given first priority for speaking opportunities, followed by Supporting Sponsors. We'll liaise directly with your chosen speaker to confirm topic suitability and key deadlines.

Event area

Disrupt talks will take place in the auditorium, sponsors will also have a table and place for a banner towards the back of the seating area. The foyer will serve as our main networking and refreshment area.

Your materials

Sponsors are responsible for providing their own materials for their sponsorship area. A trestle table will be provided to set up and display merchandise. If you need to deliver materials to the venue in advance, please let us know and we'll share delivery details. Ensure all items are clearly labelled so they can be easily identified later.

Tickets

Tickets for **Disrupt St Helier** will be available via **Eventbrite**. Depending on your sponsorship package, you'll receive complimentary tickets for the event, which can be allocated to staff or clients. As a Sponsor, you'll also receive a discount code for additional tickets.

Setting up

We expect to have access to the Freedom Centre from 13:30 on the afternoon of the event. While the audio-visual team will be setting up in the auditorium, the foyer and Sponsor areas should be available for you to set up your stand. Sponsors are responsible for ensuring all materials are set up before the event begins and removed afterward.

Audience

The Freedom Centre auditorium will be setup theatre style with **200+ seats**.

While Disrupt began as an HR-focused event, it has evolved to explore the **future of work** more broadly.

As a result, professionals from a wide range of sectors now attend making it a diverse and dynamic audience with something for everyone.

Payment

Invoices will be issued to Sponsors by the **end of January 2026**. Payment terms are **30 days**, and full payment must be received before participation in the event.

Cancellation

We've never had to cancel a Disrupt event, but in the unlikely event that circumstances require it, our cancellation policy (outlined in the full terms and conditions of this document) will apply.

Day Rehearsal
